ROLES & RESPONSIBILITIES

3. To promote gender equity & sensitization in curricular and co-curricular activities
4. To enhance specific facilities for women on campus in terms of Safety and security, Counseling, Common Rooms, Day care center for young children (if possible).
5. To increase the awareness and raise women related issues and address to gender sensitizing problems
6. To prepare annual gender sensitization action plan.
7. To examine all grievance letters received from the women staff/students regarding the sexual harassment in association with Sexual harassment committee.
8. To examine and investigate on each complaint received from the women staff/ students by collecting the required information from connected people.
9. To give feedback to the women staff/students concerned/ to find solution for their grievances.

The committee will record such grievances received from the women staff/ students in a separate register maintained exclusively for this purpose. The reply given by the committee to the women staff/students for grievance should also be recorded in the register.


